An environmental site assessment is a report prepared for a real estate holding that identifies potential or existing environmental contamination liabilities. The analysis typically addresses both the underlying land as well as physical improvements to the property. If the Phase I assessment determines a site is considered contaminated, a Phase II environmental site assessment may be conducted including a more detailed investigation involving chemical analysis for hazardous substances. The actual sampling of soil, air, groundwater and/or building materials is typically not conducted unless a Phase II site assessment is required.
