Laboratory Training At Its Best

Laboratory testing is an integral part of all water and wastewater treatment programs, regardless of how big or small. Many facilities are able to perform a portion of the required tests on-site, but must use a certified laboratory for the remaining tests. For the systems that perform any of their own tests, DEQ requires that the laboratory operators who are in general supervision of waterworks or wastewater works laboratory control tests be properly certified according to ODEQ Rules and Regulations Title 252:710.

These tests determine if the water is being adequately treated and help protect the public from waterborne diseases such as cholera, dysentery, giardiasis, and infection from E. coli to name just a few. Improper technique when performing any laboratory tests and a lack of

Quality Control measures can often result in inaccurate analyses. That is why it so important that laboratory technicians are well-trained for the tests they will be performing for their treatment system.
